- 1. How many flats in the building are council flats and how many are owned by leaseholders?
- 2. How do you allocate the costs of hot water heating and lighting amongst the flats? Is it by square footage per flat?
- 3. How do we get on a heating meter ASAP (which is what is happening at many other buildings currently) in order to reduce my charges? I am barely there as I'm a full time medical student and I only have a very small one-bedroom flat. It feels very unfair for the charges to increase by over 3 fold given these facts, and since I moved in in Feb not anticipating how much charges would increase by one month later in March.
- 4. Is there a timeline on when the heating meters will be installed ^ and how it will work/costs will be readjusted?

Hi

I have e-mailed leaseholder services 5 times with the following questions and have not had my questions answered (only once did they respond within ten days). So I have the following questions for Geraldine:

1) I have been told that the estimated gas use for my estate (Charlton Court) is 1,059,638 kWh for the coming year. Assuming that we are being charged 8.53p/kWh for gas the total charge for the estate should be £90526.54 which when divided by 55 (number of flats on the estate) equates to around £1646. My gas/hot water/heating charge is more than double that figure. I'm aware that apportionment works according to the size of flats but my 2 bed flat is average for the estate. Can you explain how the apportionment for each flat is figured out? Thanks
